Luther advises Groupe Briand on acquisition of Astron Buildings

Frankfurt am Main – Luther, in an integrated team together with Fidal, the other founding member of unyer, advised the French Groupe Briand on the acquisition of the Luxembourg-based Astron Buildings group.

As part of the cross-border transaction, Groupe Briand acquired the entire Astron Buildings Group with locations in Luxembourg, the Czech Republic, Russia, Germany, Poland, Hungary and France. Following clearance by the Russian antitrust authorities, the transaction was completed by the end of 2021. The seller of Astron was Lindab AB, which is listed on the Stockholm Stock Exchange.

Astron is a leading European supplier in industrial and steel systems construction. With around 700 employees, Astron offers sustainable, customised steel building solutions, particularly in the areas of hall construction for trade and commerce, office buildings and multi-storey car parks. Through this strategic acquisition, Groupe Briand, which has so far been represented mainly in France and Africa, is positioning itself in the pan-European market and opening up the market in Russia, where it has not yet been present.

Fidal took the lead in the overall transaction and the contract negotiations. Luther, together with its local partner law firms, carried out the due diligence in the relevant jurisdictions, coordinated centrally and managed the implementation of the transaction in Germany.
