## Luther advises GP Papenburg on sale to HIH Healthcare Fund

Leipzig, 28.09.2022 – GP Günter Papenburg AG has sold part of the "Neue Ortsmitte" neighbourhood development in Michendorf near Potsdam to Hamburg-based HIH Invest Real Estate as the first property for the open-ended special AIF "Vita Invest". The project development comprises two separate four-storey buildings: a health centre of approx. 1,600 square metres and an administration building of just under 2,000 square metres that has already been built and rented by a local energy supplier. Completion of the health centre, which will be occupied by a local home nursing service as well as doctors' practices and therapeutic facilities, among others, is planned for the end of 2023.
