Luther advises urban developer AOC on sale of Dresden construction project to Fundamenta Group fund

Leipzig, 30.09.2022 – AOC | Die Stadtentwickler GmbH, a specialist in the realisation of construction projects in central and northern Germany, has sold the "Löbtauer Tor" ensemble in Dresden to a fund of Fundamenta Group Deutschland AG. For Fundamenta as asset manager, this transaction represents one of the largest deals in Germany to date. The urban developers were advised on the sale by the real estate team of Luther Rechtsanwaltsgesellschaft.

The "Löbtauer Tor" project in Dresden was sold to the "FG Wohnen Deutschland" fund initiated by Fundamenta Group Deutschland AG. The parties involved have agreed not to disclose the sales price.

The project in the Löbtau district comprises a three-part building complex with a total lettable area of around 13,000 square metres - approximately 10,000 square metres of which are residential, while around 3,000 square metres will be used for commercial purposes in the future. The high proportion of office space in the project and the creation of high-quality residential space will relieve the Dresden real estate market. Construction work on Löbtauer Tor will start in autumn 2022: a building block with six full storeys is planned, whereby the ground floor and the first floor are planned for flexible use as office, as well as retail space.
