# Law firm ranking "Kanzleimonitor 2021/2022": 130 in-house lawyers recommend Luther

Cologne – The German law firm ranking "Kanzleimonitor" has been published again this year. Around 860 in-house lawyers were asked about their satisfaction in working with legal advisors. The results speak for themselves:

Luther is recommended in a total of 22 areas of law – particularly in employment law, energy law and corporate law. Luther achieved a top 5 ranking in each of these areas. In the overall ranking, Luther received 130 recommendations: once again more recommendations than in the previous year.
