## Luther advises E.ON on acquisition of majority stake in Clean Tech company envelio

Cologne – Luther Rechtsanwaltsgesellschaft has advised E.ON on the acquisition of a majority stake in envelio GmbH, a clean tech software company based in Cologne. The acquisition is part of E.ON's efforts to create an open digital energy ecosystem – including for charging e-vehicles. In October 2021, Luther advised the energy group on the acquisition of a majority stake in the start-up gridX, one of the leading providers of smart grid intelligence in the energy sector.

In the course of the energy transition, more and more decentralised renewable energies and wallboxes for charging e-vehicles need to be connected to the grid. envelio has already been working with the E.ON distribution system operators (DSOs) Westnetz and E.DIS for three years. The company was founded in 2017 as a spin-off from RWTH Aachen University and has a diverse and international team of more than 70 employees.
