Luther advises French real estate investment company Icade on sale of its German portfolio

Frankfurt – Icade is withdrawing from the German real estate market: At the beginning of June the French real estate investment company sold most of its assets in Germany – including an office building in Munich and two plots in Berlin. German law firm Luther and the French tax advisory firm Arsène Taxand – both members of the worldwide organisation Taxand – advised Icade on the sale of the office property with regard to tax issues. Luther has advised the company on several occasions in recent years.

The focus of Icade's future business will be the commercial sector of Greater Paris. Therefore, it recently sold the office building ICADE Munich (plot size 59,154 sqm) to a group of international investors. Moreover, the company sold two plots in Berlin (7,335 sqm in total) to a Berlin development company. Icade was legally assisted by the German law firms Görg and Hoffmann Liebs Fritsch & Partner.

Negotiations are currently in progress on the sale of two further assets of Icade's portfolio. A plot of 19,524 sqm in Dusseldorf and a building with a usable floor area of 9,475 sqm will also be sold soon.

Following these transactions Icade will have a complex of two office buildings and a plot in Frankfurt in its portfolio yet. This plot shall be marketed for the further use by a local development company before the end of this year.
