# Luther advises Handte group in the takeover of the worldwide market leader Camfil S.A.

Stuttgart – Luther Rechtsanwaltsgesellschaft mbH has advised the partners of the German Handte group in the sale of the company to the Swedish Camfil S.A. – the world market leader in the manufacturing of air filters and air cleansing products – in legal and tax questions.

On 31 January 2014 the Handte group and Camfil S.A. contractually agreed that 100 percent of all shares in Handte shall transfer to the Swedish group. The clearance by cartel authorities has not been approved yet.

Handte is Germany's number one in the manufacturing of technologies for industrial air cleansing. Handte group consists of four enterprises, among them two companies in the Czech Republic and in China, which will all transfer to Camfil S.A.
