Luther advises Federal Real Estate Agency on the German Government's first PPP building project

Essen/Berlin, 4 August 2011 – Yesterday, the Federal Real Estate Agency (Bundesanstalt für Immobilienaufgaben – "BImA") awarded the contract for the construction of the new Berlin-based seat of the Federal Ministry for Education and Research (Bundesministerium für Bildung und Forschung – "BMBF"). This represents the first federal project of construction and operation of a civil government building in the form of a PPP. Luther advised the BImA throughout the entire tender procedure.

The contract was awarded to a bidding consortium of BAM Deutschland AG and Amber Infrastructure Ltd. The new ministerial building, which will have a gross floor space of approx. 54,000 sqm, will be built on a property located east of Berlin's central train station which borders the so-called "Spreebogen" of the River Spree and faces the Chancellor's Office and the Reichstag, the house of the German parliament. The building which will be constructed on a turn-key basis is expected to be handed over in the autumn of 2014.

During the tender procedure, the BImA placed particular importance on ensuring that the new building is highly sustainable and of excellent urban and architectural quality. For this purpose, a special body consisting of well-known architectural experts was employed. Another key aspect was the cost efficiency of the building project. "The tender procedure showed that PPPs and building culture are not mutually exclusive," said Henner M. Puppel, Luther's lead partner. "By opting for the PPP model, as opposed to a conventional public construction, the public sector will save approximately 10 percent of the costs while getting the same quality. During the 30-year term of the contract, this will save costs in the net present value of more than EUR 28 million."

Puppel added: "This PPP tender procedure has proven to be a reliable basis for meeting the user's requirements." The new ministerial building will qualify for "gold", which is the highest award that can be obtained according to the assessment system "sustainable building for government buildings." The building will receive its energy supply by using a smart grid to integrate various different system components. The smart grid will combine inter alia a gas-fired fuel cell, a cogeneration unit for the generation of cold, heat and power, and photovoltaic elements on the roof and the façade of the building.
