# Luther advises Hitachi on the purchase of Xervon Energy

Dusseldorf – Hitachi Power Europe GmbH (HPE) has taken over Xervon Energy GmbH, a leading international service provider in the energy and power plant sector. German Law firm Luther Rechtsanwaltsgesellschaft advised the company on this transaction.
