### **Luther advises the Australian mining group Indo Gold on exploration in the Ore Mountains**

**Freiberg – The Australian mining group Indo Gold Ltd. is planning an exploration project in the Western part of the Ore Mountains. The aim of the project is to extract tin, wolfram and other minerals. Luther Rechtsanwalts-gesellschaft mbH advised Indo Gold on the mining concession procedures and the incorporation and management of the project company.**

Together with the Freiberg-based company Beak Consultants GmbH, Indo Gold intends to develop a specific treatment process on the basis of a feasibility study over the next few years. Up to EUR 10 million will be invested in this project over the next one to two years: providing a major economic boost to the Western region of the Ore Mountains.

Saxore Bergbau GmbH, a newly established company in Germany belonging to the Indo Gold group, has already been granted three exploration licenses. The treatment technologies developed in Australia will now also be used in Saxony to make the mining of tin and other mineral resources in the mining region profitable once again.
