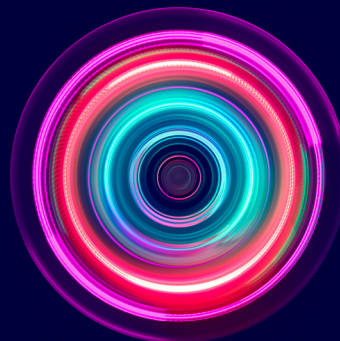

JUVE

Luther has won the prestigious JUVE Award "Law Firm of the Year 2019". 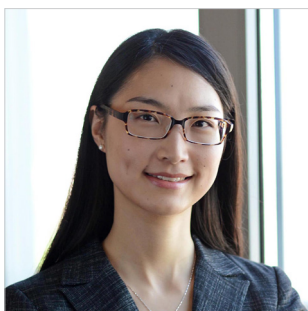

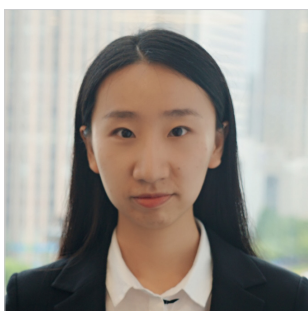

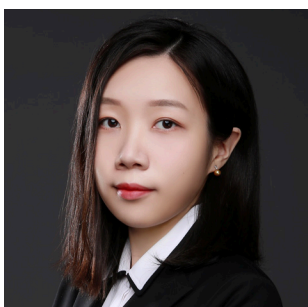
